We had **49** walkers who registered & completed this 10K hike. **29 hiked for IVV credit** while **20 did it just to experience the flora and wildlife up close and personal.** This being our third year hiking Ka'ena Point, we were still able to see the **Moli** (Laysan Albatross) and get to "hear" the sounds of the **'Ua'u Kani bird**(Puffinus pacificus). Our experience was complete as we also saw the **Ilima Papa, Pohinahina, Nehe, 'Ohai, Naupaka Kahakai, Ma'o and the Pa'u O Hi'iaka.** This year was the first time that we got to meet and talk to the marine biologists. They shared that "the Moli chick" is left alone for a period of time so that the parents can then fly back to Alaska to get food for the chick. They then fly all the way back to Ka'ena Point Refuge with their bills full of food for their offspring. *Simply amazing!* 

We were happy to have walkers **Kay Rowley & Brad Blegen of Washington State,** who shared their experience of that day; "the walk was wonderful—just loved getting out for exercise, fresh air, seeing the ocean waves, whale spouts, albatross, a baby chick & a burrow with a sheertail in it. Enjoyed your friendly people as well." We also had **Sheila & Bob Morrison of the Capitol Volkssport Club of Washington State.** They also enjoyed this event and had lunch with Barbara Mateo-Kihano & Percy Kihano at Haleiwa's Kuaaina Sandwich shop after the event. For those of you who joined the Menehune Marchers in 1987, may remember that charter club members Barbara & Michael Hays of Washington also belonged to the Capitol Volkssport Club of Washington.

the years, the Menehune Marchers Over has held Christmas parties on a non-regular basis. Those I attended were always fun; whether at a library or at the Cannon Club. What Dawn did to make the Christmas party different was to combine the party with the viewing of the downtown Christmas lights. It was not surprising that people showed up for the walk. What was surprising was who showed up; club members who seldom attended an event and friends of club members who were not regular walkers. The walk was followed by dinner at the nearby Columbia Inn and dessert provided by Gordon Harada who baked a haupia cake. The event was a signature Dawn event; the bringing together of people who would not ordinarily meet one another.

The Inaugural Big Island Volks Trip During the "Pre-Dawn Days" traveling to the neighbor islands for walks was done on an individual basis. Dawn initiated the first Big Island Volks Trip. Twenty of us traveled from Hilo to Volcanoes National Park and on to Kona in a caravan of three minivans. Dawn planned the itinerary, booked the vans and rooms in Kona, ensured everyone had accommodations at the Kilauea Military Camp, took pre-orders for lunch, had snacks for us after the Volcanoes walk, and was our tour quide during the non-walking hours. She even booked a rental car for Harriet Miyasaki and me when we told her we wanted to visit a friend in Waimea on the last day of our Big Island Volks Trip. Dawn kept in touch with us throughout the Big Island trip to ensure that things were going well. When I spoke to her about a problem with our room in Kona, she saw to it that we were moved to a more suitable room. It was a demonstration of her "can do" attitude coupled with her natural inclination to make people happy. There have been subsequent Big Island Volks Trips but the inaugural trip has remained a favorite.

Dawn Miyashiro passed away on March 7, 2008 at the age of 50. She was a long-time member of the Menehune Marchers and a staunch supporter of volkssporting.

In her earlier years as a volksmarcher she would quietly show up at events with her "walk-man" and walk by herself. Later on she brought her friend, Gordon Harada to walk with her. Gordon became a faithful supporter of Dawn and the club as Dawn felt comfortable to volunteer for various tasks. As Publicity and Media Coordinator she saw to it that our events were published in the Honolulu Weekly, Windward Press, etc. She later volunteered to be POC for the Manoa and the Downtown YREs.

Dawn suffered her first stroke in December of 2000. She was determined to walk again and was looking forward to doing all of the YREs. In a note to Marsha & Gilbert Okada she wrote: "Although I could barely walk, I made every effort to leave Rehab within a week. Gordon and I will walk around Manoa during the weekdays since there's less traffic."

Dawn had not fully recovered from her illness but she was more than willing to serve as President of the club from January 2003, to January 2004. In her messages as President, she always encouraged the members to bring a friend to our walks and to try out volksmarching. She made every effort to be there at our events; pleasantly greeting the walkers and helping out at the start/finish point"
