Dear Sam,

Please circulate this as appropriate. Thanks. Nancy Weinstein:

The Ken's Market startpoint for FS Family Wanderers' Top of the Hill/ Back of the Hill (YRE1529), and Counterbalance (YRE1530) year round events is no longer valid. POCs are looking for a new one in the vicinity and will put the word out as soon as we secure it. Thank you for your patience and understanding.

2. Due to a liability issue, the restrooms at the Charleston, OR, Arago Pack Trail and Shore Acres Garden, Y1763 registration point, Chuck's Seafood, are no longer available for public use. There are restrooms available at Sunset Beach about one mile away as you drive to the 5K or 10K trailheads. Restrooms are also available at the 10K trailhead which is about six miles from Chuck's. We apologize for the inconvenience.

3. FS Family Wanderers year round events #1529 and 1530, Queen Anne Top of the Hill, Back of the Hill and Counterbalance, now start and finish at the Bustle Cafe, located at 535 W McGraw St.The cafe is open 5:00 a.m. to 9:00 p.m., Monday through Thursday, 5:00 a.m. to 6:00 p.m. Friday, 6:00 a.m. to 6:00 p.m. Saturday and 7:00 a.m. to 8:00 p.m. on Sunday. Follow the same driving directions, as the cafe is across the street from the previous startpoint, and continue to park on the street or take Metro bus #2 or #13 when doing these walks. 4. The National Executive Council (NEC), in a closed session on Friday Feb 18, exercised its right in accordance with the AVA Bylaws .to approve the hiring of the Executive Director. By a majority vote, the hiring was disapproved. As a result of the vote, the President and Vice President resigned. As this situation was not covered by the Bylaws, the remaining members elected Dennis Michele, SE Regional Director as interim president until new elections were held at the upcoming convention. Marvin Stokes, treasurer, was elected interim Vice President, Both men, as required by the Bylaws, resigned from their previous respective positions on the NEC. Annette Tollett was elected to fill the vacant

treasurers position. These actions were necessary to complete the NEC meeting and the business before it which had to be accomplished.

From a personal stand point, it is regrettable that these matters had to be done, but it was necessary to keep the NEC and the AVA operating. I take no great pleasure in bring interim President and will not seek election to this position at the upcoming elections at the convention

5. Results of voting on the five motions before the National Executive Council:

Motion A. The everyday use of the stamp at YREs. I withdrew the motion because the council would have voted it down. Rather than create more tension, I withdrew the motion, to be considered at a later date. The first meeting after convention, I will resubmit the motion.

Motion B. The requirement to inform YRE and seasonal participants of any difference between the registration point and the actual event start point. This motion passed.

Motion C. This motion dealt with New Walker Coupons. There were modifications but this passed. Every place where it referred to Regular Events, that wording should be changed to Traditional Events. Every place where it referred to the IVV stamp, the term IVV certification stamp was substituted, and the fourth paragraph was deleted entirely.

Motion D. Restricting pre- and post – convention events. This motion failed.

Motion E. Reporting actual vs advertised distance at events. This motion passed.

6. New Special events which will begin on January 1, 2012. These will replace the many that ended in December 2010 and those which will end December 2011.

- a. Celebrating Golden Cinemas movie theater buildings
- b. Works Progress Administration Projects qualifications to be published soon
- c. America's Bakeries does not conflict with International Bakeries
- d. Strolling Somewhere Over the Rainbow must have a color in the town or location name, such as Yellowstone, Red River, Silver Falls, etc
- e. Classic American Diners qualifications to be published soon

- f. America's Murals does not conflict with NW region challenges
- g. Main Street qualifications to be published soon
- 7. Other changes.

AVA will adopt Canada's rating system. This will be defined before convention.

Wording in the AVA Policy Manual will be updated to show that the AVA convention may be held in April, May, or June. Regardless of when the convention is held, the term of office for officers and Regional Directors will begin on July 1 following the convention and end on June 30.

Cost of shipping from AVA to clubs and individuals will be updated so that clubs and individuals will bear these costs.

Ultimately, the cost of production of start cards and trail marking supplies will be passed on to the clubs.

At this time, when a person sends in a completed event or distance book, they receive a card that allows them to receive up to 4 books with AVA paying for shipping. This stops until AVA is solvent.

State associations will pay \$50 annually to be a club as do regular clubs.

8. AVA has often said that most of the organization's problems can be solved by increasing participation. Northwest Region and two other regions are doing just that. We are holding up our end of the bargain. The other regions continue their decline, some more drastic than others. Northwest Region continues to add approximately 1000 more participants each year. We have approximately 27% of all participation nationwide – that percentage is for Traditional events and YRE/seasonals as well as the combined totals. We also have approximately 27% of the free/non-IVV participants nationwide. This proves the value of allowing free participants. There are regions where they don't allow free walkers (or say they don't), but people continue to show up and be allowed to walk for free. Of course, it's impossible to deny participants at YREs the opportunity to walk for free, and from the statistics just shown, inadvisable to try to cut off free walking at traditional events.

9. (From my point of view - the world according to Sam) - I am indeed dismayed that events resulted in the dismissal of Nicole Rogers. Sure, her ideas were

radical, but I think she was just what AVA needed to be shaken out of its lethargy to become a financially viable organization. I fear that her dismissal will allow some to return to their sleepiness. For those of you who wanted no change or change at a much slower rate, you have your way, but in rebuilding the organization, we will now have to reinvent the wheel, if that is possible at this juncture. I feel that it was a short-sighted decision based not on any particular action she had taken, but on what she proposed. It is my understanding that it is the duty of the National Executive Council to control events, whether real or proposed. I feel that the council fell short in its decision.

All Weather Walkers Meeting Minutes February 8, 2011; 6:30PM Legacy Salmon Creek Medical Center

Jan Breneman called the meeting to order at 6:30 pm.

<u>Present:</u> Pat Gorman (Secretary), Joe Titone (Newsletter Editor), Dick Baker, Barbara Baker, Jan Breneman (President), Jean Moeller, , Linda Jean Barneson, Leah Riedel, Liz Connors, Carol Colvin, Lucy Schiebel (guest), Earl Bowen, and Joan Heins.

All present introduced themselves and welcomed a new member and a guest. The minutes of the December 14th, 2010 Meeting were approved as submitted. <u>Treasurer's Report</u>: Jean reported for the months of December and January because of the cancelled meeting in January. The account balance as of 12/31/10 was \$2,641.64. There were \$312.10 in expenses and \$212.52 in income during December. The balance as of 1/31/2011 is \$2,942.64 With January expenses of \$101.00 and income of \$402. Jean reported that we actually made 58 cents per book on the Starting Point Books.

<u>Membership Committee:</u> There are currently 44 club members. We have two new members and it is dues renewal time. 50% have renewed.

Weekend Walks: Eight clubs did eight walks in January with 296 walkers for the month.

<u>Wednesday Walks</u>: The February 9th walk starts here at Legacy Salmon Creek Medical Center. Dick had been away so did not have numbers of participants of recent walks.

Old Business

Jill McLean donates copies of the new year's YRE directions/maps for AWW. Fliers are available for the Fruit Valley Walk scheduled for March 19, 2011. There will be 5/10/15 K routes and directions for all three distances.

Lookout Ridge will be 5/28/11. Jan is working to get it down to a 10K. Jan reported that the City of Camas is asking for \$25 plus a certificate of insurance to approve this walk. She will get the Pathfinder ad completed by the end of February. The starting point will be on Third Avenue by the old bowling alley. The Moulton Falls walk will use the same route as before.

The Ridgefield Bird Fest is scheduled for October 8th. It is expected they will approve our plan for a walk on that date but it will not be final until their next Board meeting. We will use the same trail as used previously and make sure information about the walk includes the fact that we walk even if weather is inclement and that part of the trail may be influenced by the weather.

Many of the books given out for the 2010 AWW Challenge have not been returned. Completed books were received from Jan, Joan and Earl. The drawing will be deferred to March to give others a chance to get the book returned. Minutes will be researched to clarify rules before a decision is made on doing the challenge again.

New Business

The PUD building has been reserved for our regular meeting date for the Annual Meeting. The meeting and potluck will be June 14, 2011. Mark your calendars. Jan read and discussed some motions being proposed for AVA.

- 1. This would allow participants to get an event stamp for a walk as often as you want as long as you pay the fees and do the walk. Approved by AWW members.
- 2. Remote starts must be published including information on the distance, facilities and support available. Approved by AWW members.
- 3. This would clarify how to report "Free Walker Coupons" in the policy manual. This would be done by the club rather than the walker. Some members felt the instructions are too complicated so feedback at AWW's meeting was mixed.
- 4. Add a paragraph in the policy manual stating that when conventions are offering IVV event clubs offer events for the week before, during and after within 400 miles. AWW is opposed
- 5. The Policy Manual would be revised to show if there are distance or route changes for a walk it is to be posted at the start rather than reported on the after action report. AWW supports this motion.

The AVA is developing a strategic plan to combat the decrease in club and members. They want to make some big changes that we will notice over the next few years.

Announcements

There is an ESVA meeting over Presidents Day Weekend (February 19-21). Dick Baker will attend.

Workers are needed for Vancouver's Discovery Walk.

The refreshment schedule is as follows: Linda - March Joe - April Barbara - May The meeting was adjourned at 7:30pm. The next meeting will be 3/08/11
