This is a Special Edition of The AVA Checkpoint to acquaint club presidents and club members with a new initiative called IVV-Americas.

Several years ago the International Federation of Popular Sports (IVV), an international organization that is composed of national associations such as the AVA, decided to develop a series of continental associations which would be subelements under the IVV. This would then allow the IVV Executive Presidium, the governing body, to focus on truly international issues. Thus, functions related to specific continents would be delegated specifically to the continental associations.

In 2010, revised IVV statutes were passed to allow for the creation of continental associations including a revised IVV structure.

For the past year or so a group of representatives from Canada, Brazil and the United States, worked on creating an organizational structure and bylaws for the creation of a continental association to be called IVV-Americas. The AVA did not have representation or take part with this working group.

The organizing committee submitted a formal motion to the IVV Presidium to create IVV-Americas on 27 July 2012. Action on this motion will take place at the forthcoming IVV Congress of Delegates in Zhaoqing, China on 20-21 October 2012. See Attachment 1. A draft of the approved IVV-Americas Bylaws, as submitted to the IVV, are at Attachment 2.

At the National Executive Council XVII Meeting in Orlando, Florida on 6-7 July 2012, the NEC voted to become an active member in the formation of the IVV Continental Association but...the AVA would join only after the implementation documents had been reviewed and approved by the NEC. Some of the NEC members believed that it was important to find out what the AVA would be getting into before joining IVV-Americas. The NEC will hold a special meeting (conference telephone call) on 8 October 2012 for the purpose of voting on the AVA Joining IVV-Americas.

Sam commented:

It is my intent at this moment to vote FOR the AVA to join IVV-Americas. AVA has 275 clubs, CVF has approximately 30 clubs, and Brazil has approximately 50 clubs. AVA should be leading in the formation of the new IVV-Americas for the simple reason that because of our size, we should dominate the formation of the organization.

Then on 10/9: Last night in a special telephonic meeting, the NEC voted to defer joining IVV-Americas until convention 2013 when the idea can be put before the AVA member clubs. As information on the topic becomes available, it will be forwarded to you.

Date: Wed, Oct 10, 2012 Subject: Washougal YR1968 (AVA 90507) Trail Changes

The Gibbons Creek trail at Steigerwald Lake NWR is closed at this time, affecting the subject YRE 5/10km routes (remote starts only). A large wildfire burned 140 acres last Friday. It started on the east side of the trailhead; winds pushed the fire across the wooden boardwalk near the trailhead entrance, and then spread rapidly to the west. Repairs are currently being assessed and the refuge and trailhead are closed until further notice. The manager "hopes to have a plan for reopening in place by late next week," which is around October 20th. Be aware that is just a plan; it could be weeks or months to finish the reconstruction.

In the meantime, walkers can do the 5k or an 11/13km route beginning directly from Papa's Ice Cream. An 11km route is possible by simply accessing the Columbia River dike trail and walking its length to the fish ladder (Mile Post 2) and back, without taking the turn through the wildlife refuge area.
